## **Evaluation of the SUPPORT Act Section 1003 Demonstration Project to Increase Provider Capacity for Substance Use Disorder Treatment and Recovery Services**

## **About the SUPPORT Act Program**

The Substance Use Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities (SUPPORT) Act was enacted on October 24, 2018. Section 1003 of the SUPPORT Act authorizes the Secretary of the Department of Health and Human Services through the Centers for Medicare & Medicaid Services (CMS), in consultation with the Director of the Agency for Healthcare Research and Quality (AHRQ) and the Assistant Secretary for Mental Health and Substance Use from Substance Abuse and Mental Health Services Administration (SAMHSA), to conduct a 54-month demonstration project (the section 1003 Demonstration) designed to increase the capacity of Medicaid providers to deliver substance use disorder (SUD) treatment, including opioid use disorder (OUD) treatment or recovery services. Section 1003 of the SUPPORT Act also requires that there be an evaluation of the demonstration. IBM Consulting is conducting a mixed-methods evaluation of the section 1003 Demonstration with support from NORC. In addition to the web-based survey described below, NORC is also administering focus groups of providers who treat Medicaid beneficiaries experiencing OUD and other SUD.

Web surveys will be administered beginning this January. Findings from this survey will help CMS, SAMHSA, and AHRQ understand how SUPPORT Act-related activities are working to improve provider capacity to prevent and treat opioid use disorder among vulnerable populations across the country.

## **Participation**

Invitations to participate in the web survey will be mailed (via USPS) or emailed during the first week of January to providers who deliver OUD treatment services. The letter or email contains a URL and QR code for the survey website and a Personal Identification Number (PIN) that has been assigned to you. All responses to the survey are strictly confidential and no individual responses will be shared with any of the sponsoring agencies.

## **Frequently Asked Questions**

- 1. Who should take the survey?
  - We are surveying providers who likely prescribe buprenorphine or administer
    methadone or other medication for opioid use disorder to Medicaid beneficiaries in the
    following states that received SUPPORT Act funding: Alabama, Connecticut, Delaware,
    District of Columbia, Illinois, Indiana, Kentucky, Maine, Michigan, Nevada, New Mexico,
    Rhode Island, Virginia, Washington, and West Virginia.
- 2. How will I complete my survey?

- Look for an email from SUPPORT-Act@norc.org or a letter invitation to take the survey.
   The email or letter will contain a unique Personal Identification Number (PIN) and a URL and QR code for you to take the survey online.
- 3. How did you receive my name and email/mailing address?
  - We obtained your contact information from the <u>SAMHSA Buprenorphine Practitioner</u> Locator, the state Medicaid agency, or from the State Opioid Treatment Authority.
- 4. What if I want to review the questionnaire before I take the survey?

- 5. Is it important that I participate?
  - Yes! Absolutely! If you were asked to participate, it is very important that your experiences are represented.
