



## What are Medicaid Home & Community-Based Services (HCBS)?



- Traditional Medicaid does not cover all services needed to support people who are aging or living with disabilities in the community.
- HCBS benefits give states a way to offer Medicaidpaid, long-term care in the community.
- "In the community" means the individual lives at home or in a non-institutional setting, such as a residential home.



### Differences between available Medicaid programs

The federal Medicaid program has different program types that States can put in place to offer HCBS.

### What is a 1915(c) HCBS Waiver?



#### To offer 1915(c) HCBS Waiver programs, states must:

- 1. Determine who is eligible, services and settings offered, and set rates and payment for providers
- 2. Provide a level of care **equal to** what an individual would receive in an institution
- 3. Demonstrate the cost of care in a home- or community-based setting is equal to or less than the cost of institutional care
- 4. Assure the quality of services and supports individuals receive



### There are six 1915(c) HCBS Medicaid Waivers in Kentucky.

## What is unique about the 1915(i) State Plan Amendment (SPA)?



#### States can develop a 1915(i) SPA HCBS program to:

- 1. Establish a **new Medicaid eligibility group** to receive HCBS
- 2. Define the supports and services included in the benefit
- Target a program and its menu of services to one or more populations using needs-based eligibility criteria
- 4. Offer the benefit **statewide** to eligible individuals. Note, when services are offered within the Medicaid state plan, they are available statewide and there are **no limits** on the number of individuals that can be enrolled.
- Offer HCBS to people who <u>do not yet</u> meet the institutional level of care (e.g., qualify for a nursing home)



# Why is the state developing a 1915(i) SPA focused on providing services for individuals with behavioral health?

# The Cabinet for Health and Family Services (The Cabinet) was directed by the Kentucky Legislature to implement a new Medicaid program:

- Senate Joint Resolution 72 directed The Cabinet to address current needs for the individuals living with Severe Mental Illness (SMI) in Kentucky.
  - The resolution stated the need for Supported Housing, Supported Employment, and Medical Respite.


### <u>Community advocates and stakeholders also indicated additional</u> <u>behavioral health needs</u>:

 The Cabinet interviewed multiple behavioral health advocates and stakeholders to identify additional needs for individuals living with SMI and Substance Use Disorder (SUD).

# 3.) 1915(i) SPA Program Overview





## What are the factors that will make someone eligible?

Individuals who seek services through the 1915(i) SPA will need to meet the following eligibility criteria based on the proposed program design:



Age and Diagnosis – 18+ with a Primary Diagnosis of Serious Mental Illness (SMI) OR Substance Use Disorder (SUD)



**Assessed Level of Need** – Level of Care Utilization System (LOCUS) **OR** American Society for Addiction Medicine (ASAM) criteria determined through an assessment by a trained professional.



**Functional Impairment** – Clear evidence of functional impairment in two or more of the following domains: 1.) Societal/Role, 2.) Interpersonal, 3.) Daily Living/Personal Care, 4.) Physical, 5.) Cognitive/Intellectual



**Duration / Episodic Criteria** that includes, clinically significant symptoms of behavioral health that have persisted in the individual for a continuous period of at least two (2) years **AND** the hospitalization of an individual for behavioral health more than once in the past two (2) years.



## What Factors Make Someone Appropriate for Services?

Not all eligible program participants will be eligible for all services. Specific services will only be available to individuals that meet certain assessment tool thresholds and risk factors.



#### **Assessment Tools:**

- An individual's LOCUS or ASAM assessment must be within the following range to be eligible for services:
  - 1) LOCUS Range: Level 3 to Level 5
  - 2) ASAM Range: Level 1.0 to Level 2.5

#### **Housing Risk Factors (Housing-Related Services Only):**

- To be eligible an individual must demonstrate one of the following risk factors:
  - 1) Homelessness
  - 2) At-risk of homelessness (Department of Housing and Urban Development (HUD) definition)
  - 3) History of frequent (more than 1/year) stays in nursing home/inpatient settings with a length of stay of at least 60 days
  - 4) Was homeless in the prior 24 months, or formerly homeless, now residing in HUD assisted housing

# The 1915(i) SPA will offer three housing-related services to put forward a full range of supports to move participants to the housing of their choice.











# 1. Tenancy Supports (SMI & SUD Eligible)

#### Offers:

- Pre-Tenancy and Tenancy Sustaining Supports
- Housing model based on PSH Principles
- Service goal is to assist individuals in identifying, obtaining, and sustaining housing in independent community settings.

# 2. In-home Independent Living Supports (SMI Eligible)

#### Offers:

- Independent Living Supports
- Housing model based on PSH Principles
- Service goal is to provide individuals with assistance and training related to Activities of Daily Living (ADLs) and Instrumental Activities of Daily Living (IADLs)

# 3. Supervised Residential Care (SMI Eligible)

#### Offers:

- 24/7 Staffed Residential Care
- Housing model based on Permanent Supportive Housing (PSH) Principles
- Service goal is to provide individuals with needed residential supports while also empowering community transitions, as appropriate.



The 1915(i) SPA will offer Supported Education and Supported Employment to promote engagement and sustain participation in a community setting.



# 4. Supported Education

(SMI & SUD Eligible)

#### <u>Individualized Placement & Support (IPS) Model</u>:

Promotes engagement, sustained participation, and restores an individual's ability to function in the learning environment.



# 5. Supported Employment

(SMI & SUD Eligible)

#### IPS Model:

Offers supports and services to obtain and maintain employment in a competitive environment.



## The 1915(i) SPA will include five additional services



**6.** <u>Assistive Technology</u> (SMI & SUD Eligible): Provides funding and support to obtain equipment, software, and/or products that increase **independence** and **support** education, employment, recreation, and activities of daily living.



**7.** <u>Case Management</u> (SMI & SUD Eligible): Provides support to individuals in obtaining needed support services, developing a Person-centered Service Plan (PCSP), and enabling them to identify goals and strategies to meet goals.



**8.** <u>Medication Management</u> (SMI Eligible): Provides support and monitoring for program participants as well as **education** and **training** to facilitate an individual's adherence to their prescribed medication.




**9.** Non-Medical Transportation Services (SMI & SUD Eligible): Provides access to covered, non-medical transportation to community services, leisure activities, and resources.



**10.** <u>Planned Respite for Caregivers</u> (SMI Eligible): Provides opportunities for primary caregivers to receive **short-term relief** from the duties associated with providing unpaid care for individuals that need ongoing care.



<u>Public Comment Overview</u>: The public notice and public comment period will be held to solicit public input on the proposed 1915(i) SPA from recipients, providers, and all stakeholders and interested parties prior to submission to the Centers for Medicare and Medicaid Services (CMS).

#### **Public Comment Period Process:**

- The Cabinet will conduct a 30-day public comment period prior to the submission of the 1915(i)
   SPA application to CMS by posting the draft application to the following website below:
