1. Services Requiring CHFS Review

After November 22, 2019, following completion of Case Supervisor review and/or any review for conflict and/or exceptional supports, if applicable, if a service does not require any further review by the CHFS Internal Reviewer, the service can be systematically approved based on what is requested. Only specific services will require additional review beyond any needed Case Supervisor or CMA Internal Review.

Below are details regarding the specific services requiring additional review by CHFS. broken down by Waiver Program.

Please note: In addition to the services mentioned, any request for Goods and Services included on a Plan for an amount exceeding \$500 will require CHFS review, regardless of program.
