#### **Public Notice**

Public Comment Period for Proposed Addition to Kentucky's 1915(c) Home and **Community Based Services Waivers** June 16, 2025

The Department for Medicaid Services (DMS) is holding a public comment period for the following new 1915(c) Home and Community Based Services (HCBS) waiver:

Kentucky Community Health for Improved Lives and Development (CHILD) Waiver

DMS is developing the Community Health for Improved Lives and Development (CHILD) 1915(c) waiver to serve children and youth until the age of 21 who meet a Hospital-Psychiatric Residential Treatment Facility (PRTF) or Intermediate Care Facility for Individuals with Intellectual Disabilities (ICF/IID) level of care. The primary goal of the CHILD 1915(c) program is to keep children, youth, and young adults with multi-system needs and complexities safe, healthy, and to the extent feasible, independent, within their communities and families. Additionally, the CHILD waiver aims to serve children, youth, and young adults regardless of custody arrangement and is dedicated to a holistic approach to addressing high-intensity needs with a support system as determined by the enrolled participant. Priority enrollment is granted to children who are in the State's custody, at risk of being unhoused or are currently unhoused or are leaving an institutional setting.

The proposed waiver application and summary of the waiver eligibility, services, and policies are available for review. All materials are posted on the DMS Division of Long-Term Services and Supports website. The formal public comment period begins June 16, 2025. DMS will receive comments until 11:59 p.m. Eastern Time on July 15, 2025. The formal public comment period is being held in accordance with 42 CFR 441.304(f), in which CMS requires states to engage the public before submitting substantive waiver changes for approval.
