| New Product to Market<br><b>Yuviwel® (navepegritide)</b> | <p><b>Non-PDL</b></p> <p><b>Approval Duration:</b> 1 year initial, 1 year renewal</p> <ul style="list-style-type: none"> <li><i>Yuviwel (navepegritide) is a C-type natriuretic peptide (CNP) analog. It is indicated to increase linear growth in pediatric patients 2 years and older with achondroplasia with open epiphyses. It is a prodrug of CNP and works similarly to the body's natural hormone. After release, CNP binds to natriuretic peptide receptor-B (NPR-B) and increases cyclic guanosine monophosphate (cGMP), which helps reduce the overactivity of fibroblast growth factor receptor 3 (FGFR3). Achondroplasia is caused by an overactive FGFR3, which slows normal bone growth and leads to short stature and skeletal differences.
