# **Application and Selection Process**

## **Beneficiary Advisory Council (BAC)**

#### Who can be part of the BAC?

BAC members are people who are currently, or have been, on Medicaid. They can also be the parents, guardians, or caregivers (paid or unpaid) of those who have Medicaid.

#### How do I apply to be on the BAC?

DMS will post applications and instructions on how to apply on the <u>BAC website</u> when there are openings. People should also sign up <u>here</u> to receive email updates about future chances to apply.

#### How are BAC members chosen?

The Commissioner and other DMS leaders review all of the applications and make the final choices. They look for people who can speak for the different Kentucky Medicaid programs and the people who use them. They also make sure to pick people from all across the state so that many voices and communities are included.

#### How will I know if I got selected to be on the BAC?

All applicants will get an email or a letter in the mail that tells you if you have been chosen to be on the BAC, or if DMS is not able to give you a position at this time.
