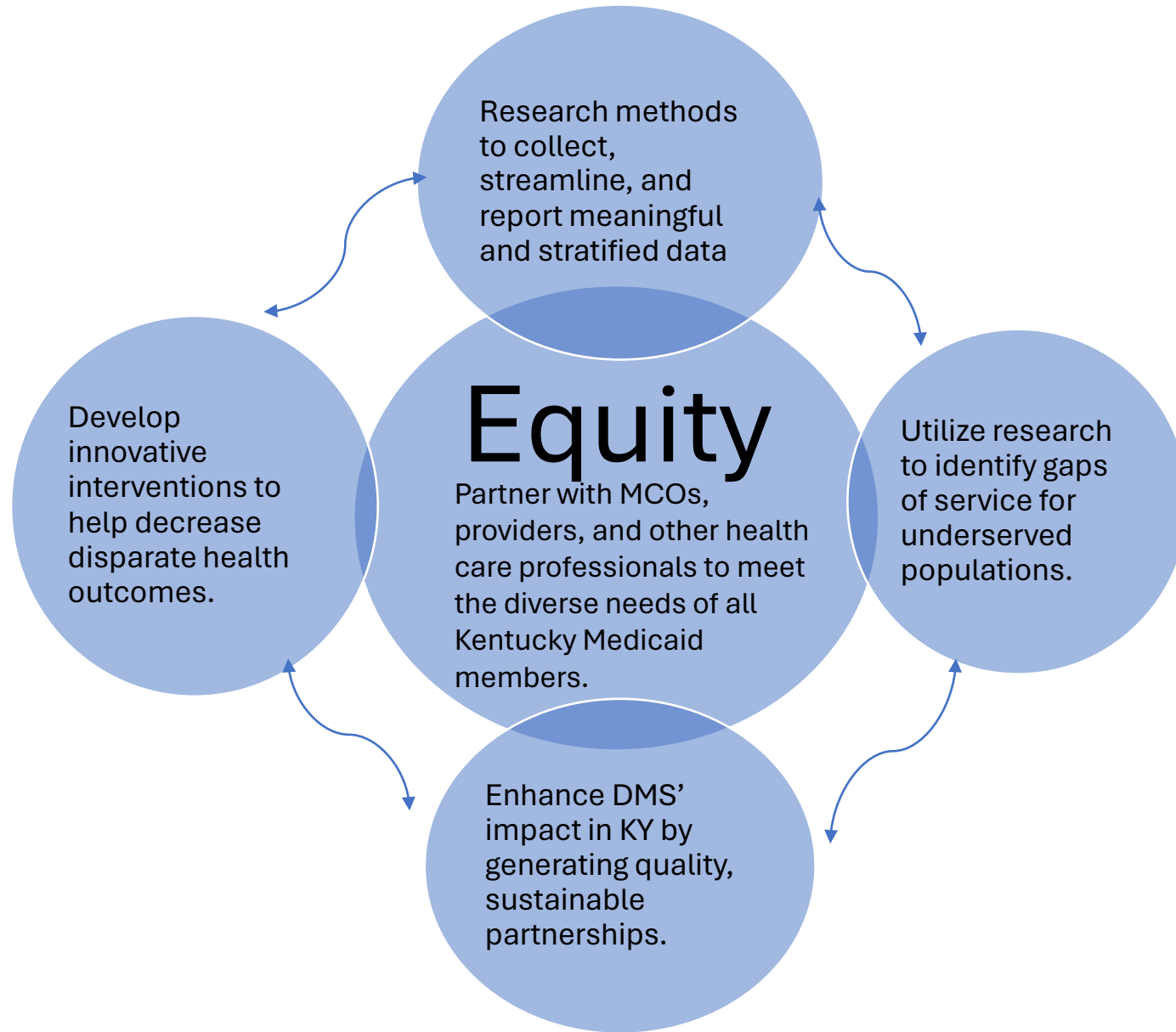

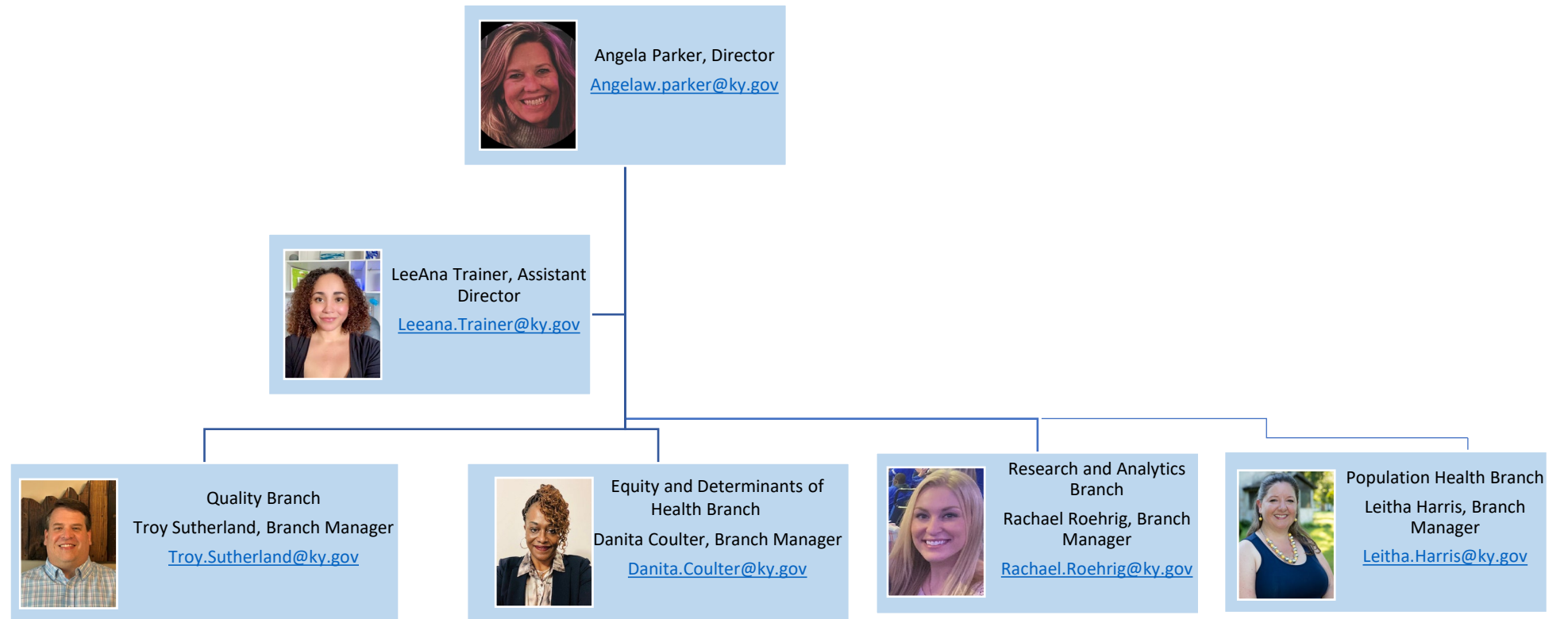

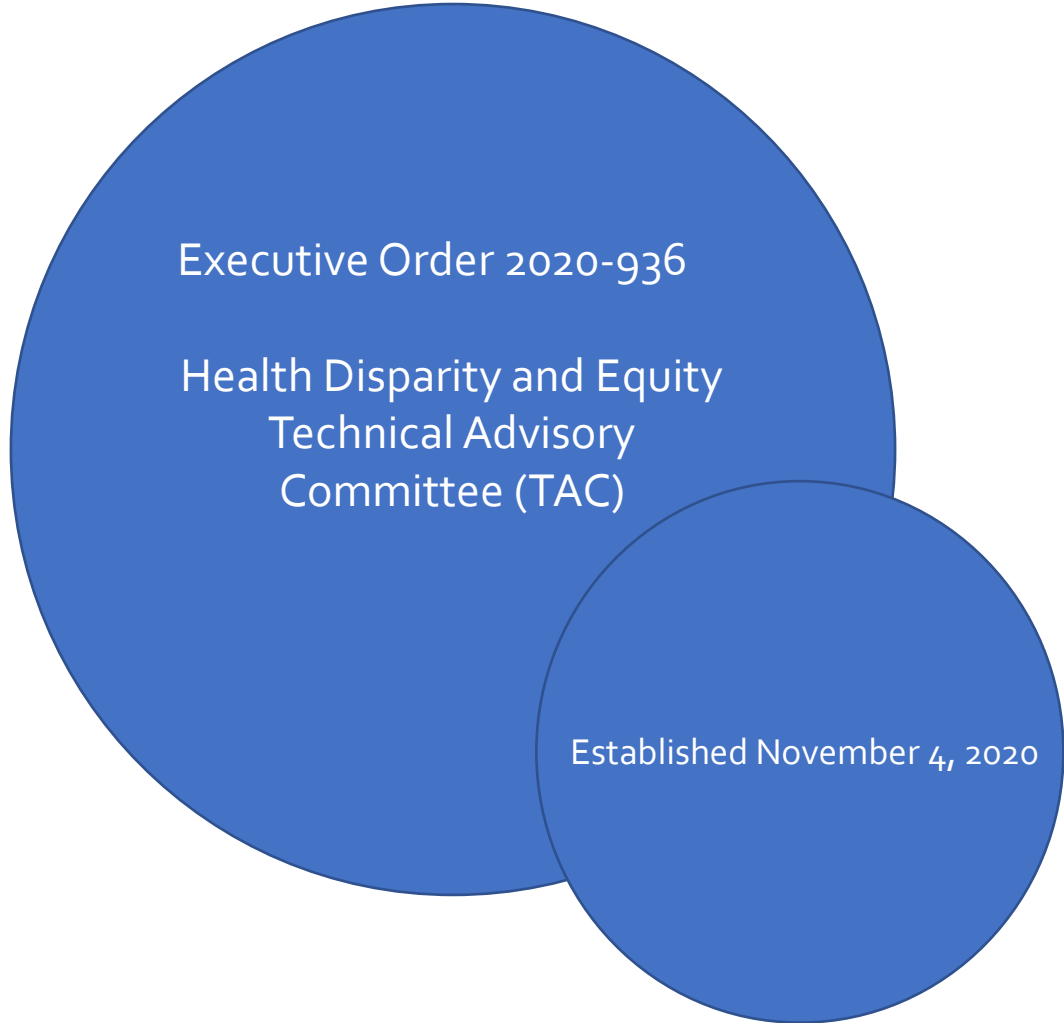


Managed Care Organizations (MCOs)

- National Committee for Quality Assurance (NCQA) Health Equity
 - Health Equity Accreditation adds new requirements to NCQA's Multicultural Health Care standards that focus on organizational diversity, equity, inclusion and reducing bias; collecting gender identity and sexual orientation data; and reporting race/ethnicity stratified HEDIS measures.
 - 3 MCOs
- National Committee for Quality Assurance (NCQA) Health Equity Plus
 - The voluntary Health Equity Accreditation Plus option includes standards for assessing and addressing social determinants of health
 - 1 MCO
