DEMOGRAPHICS

Minority Populations by Counties

- In 2011, the majority of the Black population in Kentucky resided mainly in the western and southern regions of the state. Fulton, Christian, and Jefferson counties' total populations are made up of more than 15% African Americans.
- According to the 2010 Census, much of the Hispanic population in Kentucky was located in the
 central and western regions of the state. Fayette, Bourbon, Christian, Woodford, Shelby, and
 Carroll counties had the largest percentages of Hispanic residents.

EDUCATION

- With the exception of Hispanics and American Indians, 4 out of 5 adults in most racial and ethnic groups have attained at least a high school education.
- Asians have the highest percentage and Hispanics at the lowest percentage of those attaining a high school education.

INCOME

- Significant disparities exist among races and ethnicities in terms of earning power.
- Asian and White households are more likely to have higher incomes than Hispanics, Blacks, and American Indians.

INSURANCE

- Blacks and Hispanics are much less likely to have health insurance coverage.
- The majority of Kentuckians have private insurance, while Blacks have the highest percentage of persons on public health insurance.

• Data including the years 2006-2010 demonstrates that ethnic and racial minorities are less likely to own their own homes in Kentucky when compared to their White counterparts.

• In Kentucky preliminary data for 2012 indicates that, cancers (malignant neoplasms) and heart disease as the two major causes of death for Blacks.
