**BUSINESS LICENSE SURETY BOND**

(For residents or non-residents of the state of Kentucky, pursuant to the provisions of KRS 211.972 and KRS 211.976.)

**KNOW ALL MEN BY THESE PRESENTS:**

That I/we \_\_\_\_\_ of \_\_\_\_\_ (hereinafter called the Principal), as Principal, and \_\_\_\_\_ of \_\_\_\_\_ (a company authorized to become Surety in the state of Kentucky or a Surety whose sufficiency has been approved by the Commissioner of Health, hereinafter called the Surety), as Surety, are held firmly bound into the COMMISSIONER OF THE DEPARTMENT FOR PUBLIC HEALTH, COMMONWEALTH OF KENTUCKY, for the benefit and purpose to protect all persons damaged by faulty workmanship in the servicing or maintaining of septic tanks, holding tanks, portable toilets, Type III marine sanitation devices, grease traps, or similar treatment works, and to guarantee the appearance of the Principal (licensee) to answer any summons (hereinafter called the Obligee) in the penal sum of five thousand dollars (\$5,000) for a resident and non-resident of the state of Kentucky for the payment of which sum well and truly to be made, the Principal and the Surety bind themselves, their heirs, executors, administrators, successors, and assigns, jointly and severally, firmly by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH. That, whereas the Principal has applied to the Commissioner of the Department of Public Health, Commonwealth of Kentucky, for Business license to engage in or offer to engage in or carry on the business of servicing or maintaining septic tanks, holding tanks, portable toilets, Type III marine sanitation devices, grease traps, or similar treatment works within the Commonwealth of Kentucky;

NOW THEREFORE, if the Principal shall well and truly comply with all the regulations and requirements imposed on him by law or ordinance regulating the work or privilege for which the license is issued; and if the Principal shall perform all such services in workmanlike and hygienic manner; and if the Principal shall not provide faulty workmanship in the servicing to maintaining of septic tanks, holding tanks, portable toilets, Type III marine sanitation devices, grease traps, or similar treatment works; and if the Principal as licensee shall appear to answer any summons within 30 days of notice to the Surety of the issuance of such summons, then, this obligation to be void, otherwise to remain in full force and effect.

A copy of this Surety Bond shall be submitted with the application for a license DFS-306 to operate a business of servicing and maintaining septic tanks, holding tanks, portable toilets, Type III marine sanitation devices, grease traps, or similar treatment works on an annual basis to the Cabinet.

KRS 371.090 provides that: "No person shall be bound as the surety of another by the act of an agent unless the authority of the agent is in writing, signed by the principal, or, if the principal does not write his name, then by his sign or mark, made in the presence of at least one creditable attesting witness."
