



FY2027 Payment Cycle Schedule

The KEIS Program reviews and approves service claims for accuracy and completeness before approving for payment. Only approved claims are processed for payment during the two-week Date of Service cycle. Claims requiring additional information (i.e., unapproved claims) may be processed after the two-week Date of Service cycle if not approved by the end of the cycle period.

Processing dates may change due to unforeseen circumstances with or without notice. For instance, payment for approved service claims may be delayed if federal or state holidays or observances coincide with a payment cycle. Service claims and EOBS are not processed on State Holidays.

Early Intervention Providers may generate a TOTS Agency Invoice Report to reconcile payments. The report is updated by the Monday after each pay cycle period.
