

KIPDA District Determination

The KIPDA District has slipped to score in the Needs Intervention category.

A determination of **Needs Intervention** means that the district must seek out targeted technical assistance and training resources on areas of non-compliance. This may include onsite technical assistance visits and monthly monitoring calls with the Point of Entry Manager and other key stakeholders.

Indicators 1, 7 and 8 are compliance indicators. The target is set by the Office of Special Education Programs (OSEP).

Indicators 2, 3, 4, 5 and 6 are performance indicators. These are a measure of the district's overall performance in several key areas. These targets were set during the development of the State Performance Plan (SPP).

For Indicators 5 and 6: For FY 2022, the general population in Kentucky was presented by age group rather than single year age. KEIS made assumptions in calculating the percentages for Indicators 5 and 6 for reporting purposes. These indicators were not included in the overall score for the district due to the lack of reliable data. KEIS anticipates single year age data will be available for FY 2023.
