### Introducing the POE Spotlight!

Our first POE Spotlight features the Kentuckiana Regional Planning and Development Agency (KIPDA) Point of Entry. First Steps services in Louisville and surrounding counties are provided through the KIPDA POE. The KIPDA First Steps POE office is managed by Melissa Phillips (formerly Melissa Robinson).

**How would you describe your team?** The KIPDA POE team is resilient, motivated, and hard-working. We are fortunate to have a highly experienced and committed team of District Child Evaluation Specialists who have been with the program many years for the most part, lending knowledge and history of the program. KIPDA also has a strong team of Service Coordinator IIs who supervise three teams of Service Coordinators. The supervision team has been instrumental in the progress of our POE over the past several years. They are knowledgeable, have an impeccable work ethic, and provide support to staff, providers, and clients without fail. Our Service Coordinators work through high caseloads and staff turnover to provide access to early intervention services. They have been especially committed to maintaining a high standard of service, learning new policies and procedures, and following all safety protocols during the COVID-19 pandemic. The glue that keeps our POE together is our Administrative Support team who has been flexible, hardworking, and shown up to support everyday even during the pandemic. #### **December 1 Child Count**

Please mark your calendar and be sure to complete all discharge summaries and progress reports by November 30. All IFSPs will be locked on this date. Child count provides a picture of the number of children enrolled in First Steps as of December 1 and is given to the Office of Special Education Programs each year as part of federal reporting. Child count is also tied to KEIS funding.

#### Policy and Procedure Manual and Billing Manual Recently Updated

The *KEIS Policy and Procedure Manual* and *Doing Business with KEIS* (billing manual) have both been recently updated. The billing manual will be housed on TOTS. The Policy and Procedure Manual is available on TOTS and <u>here</u> under "Guidance Documents." A huge amount of time and effort went into these updates, and we hope they will be helpful to you.

## **OT and OTA License Renewal**

Most OT and OTA licenses are due for renewal prior to December 31, 2021. Due to possible delays associated with the pandemic, it is highly recommended that providers begin the renewal process early. #### **Contract Renewal Coming Soon**

The new year will bring a new contract season. Contract renewal for POEs will begin in May 2022. Things to think about collecting for renewal include staff's professional licensure, training record print outs from Adobe, any training certificates for trainings taken outside of Adobe (example: Bayley 4 training), and NPI details page print outs. The SLA plans to use DocuSign in hopes of making renewal a little less stressful!
