

# **Purchase District Determination**

The Purchase District has slipped to score in the Needs Assistance category.

A determination of **Needs Assistance** means that the district must seek out targeted technical assistance and training resources on areas of non-compliance. This may include onsite technical assistance visits and monthly monitoring calls with the Point of Entry Manager and other key stakeholders.

Indicators 1, 7 and 8 are compliance indicators. The target is set by the Office of Special Education Programs (OSEP).

Indicators 2, 3, 4, 5 and 6 are performance indicators. These are a measure of the district's overall performance in several key areas. These targets were set during the development of the State Performance Plan (SPP).
