# 2020 ANNUAL ADMINISTRATIVE CLAIMS DATA REPORT – CARDIAC CATHETERIZATION

## INTRODUCTION

Thank you for your interest in the **2020 Annual Administrative Claims Data Report – Cardiac Catheterization**. This report covers the utilization of Cardiac Catheterization Labs by licensed Kentucky hospitals for the calendar year January 1, through December 31, 2020. The administrative claims data, submitted by hospitals and ambulatory facilities as required by 900 KAR 7:030 – Data Reporting by Health Care Providers, was used to produce the utilization information in this report.

The Kentucky Annual Administrative Claims Data Report – Cardiac Catheterization uses administrative claims data to determine utilization. Table 1 of this report details the hospitals, including the number of cardiac catheterization labs, authorized to provide catheterization services. The source of this information comes from the Certificate of Need Inventory, which may be viewed on the following web site: <https://chfs.ky.gov/agencies/os/oig/dcn/Pages/inventory.aspx>.

Cardiac catheterization is a diagnostic or therapeutic procedure in which a catheter is introduced into a large vein or artery, usually of an arm or leg, and threaded through the circulatory system to the heart. A single procedure lasts from the time the catheter is inserted until the time that the catheter is completely withdrawn from the patient. With regard to cardiac catheterization services the term “laboratory” (lab) means each dedicated room within a fixed-site facility which is individually equipped and staffed for the purposes of performing cardiac catheterizations.

The claims are counted in three ways. The number of procedures classified as “All Therapeutic” is a count of administrative claims records where the record included at least one therapeutic code, regardless of the presence of any diagnostic codes. Similarly, the number of procedures classified as “All Diagnostic” is simply a count of administrative claims records where the record included at least one diagnostic code, regardless of the presence of any therapeutic codes. Finally, the number of procedures classified as “Therapeutic and Diagnostic” is a count of the number of claims records where the record included at least one diagnostic code AND at least one therapeutic code. This count overlaps the other two counts.


To determine the number of cardiac catheterizations performed, each administrative claim record was examined to determine if it contained at least one of the following procedure codes. Inpatient Hospital Discharge records were examined for ICD-10 Procedure codes, while Outpatient Services Records were examined for CPT Procedure codes.

## Summary of 2020 Data

In 2020, cardiac catheterization procedures were performed in 49 Kentucky hospitals, located in 32 counties. There were 9 hospitals with a total of 10 labs, licensed to perform diagnostic catheterizations only. There were 37 hospitals, with a total of 106 labs, licensed as comprehensive, which can perform both diagnostic and therapeutic catheterizations. There were 41,688 diagnostic catheterizations performed and 15,296 therapeutic catheterizations performed. The volume of diagnostic procedures decreased by 13,841 and the volume of therapeutic decreased by 4,828 since 2019. These decreases were affected by the Covid-19 Pandemic.


“Pediatric” means the patient age is 17 years or less. “Adult” means the patient age is 18 years or greater.


