

Anderson County received \$320,880 in funding. Donations and volunteer time totaled \$372,400. Additional grants totaled \$50,000. Throughout the Commonwealth 84% of all enrolled students received at least one FRYSC service. Over 26,000 caregivers participated in Grandparent/Relative Support Groups, and over 36,000 students participated in FRYSC-sponsored mentoring programs.

Anderson County received \$28,995 from the Child Care Assistance Program issuance, supporting up to 60 providers a month. The Division of Child Support Enforcement served 802 children, collecting \$1,482,932 in current and past due child support, during fiscal year 2023. The agency established 720 orders.

There were 55 children cared for by foster families, 36 of whom received a combined per-diem totaling \$3,403.

52% of children in foster care had a goal of adoption. 47% had a goal other than adoption (e.g. reunification).
