


# **Boone County - Fiscal Year 2024**

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 3 members in Boone County.

#### Kentucky Transitional Assistance Program (KTAP)

Your county received \$578,954 in KTAP issuance. This has been allocated to 159 households in the past fiscal year.



On average, SNAP supported 7,119 people a month in Boone County, stretching over 2,800 households.

## **Health Services**

Funding to Northern Kentucky District Health Department: \$10,193,947

During fiscal year 2024, in Boone county there were 54 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 3,168 participants who received benefits totaling \$2,804,949.

There are 10 WIC-approved grocers in Boone County.

## Division of Family Resource and Youth Services Centers (FRYSC)

Boone County received \$1,463,855 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 18,028, and 44% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$1,168,251. Additional grants totaled \$9,100.

Boone County received \$7,952,600 from the Child Care Assistance Program issuance, supporting up to 1,406 providers a year.

The Division of Child Support Enforcement served 4,706 children, collecting \$11,600,929 in current and past due child support, during fiscal year 2024. The agency established 4,086 orders.

There were 87 children cared for by foster families, 68 of whom received a combined per-diem totaling \$5,911.

5% of children in foster care had a goal of adoption. 94% had a goal other than adoption (e.g. reunification).

According to KASPER data, 33,718 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 62,985 of the 196,750 total controlled prescriptions dispensed.
