Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Bourbon County received \$676,007 in funding, grants, community cash, and in-kind contributions with 6 full-time staff and 2 part-time staff.

As of 7/3/2022, there were 29 children in Out of Home Care, 27 of which received a per-diem, for a daily per-diem of 1,751.

27% of children in the state's care had a goal of adoption. 72% had a goal other than adoption (e.g. reunification).

Bourbon County received \$766,175 from the Child Care Assistance Program issuance supporting up to 187 providers a month. The Division of Child Support Enforcement served on average 938 children a month, collecting \$1,836,226 in current and past due child support during FY 2022. They established 37 orders.
