



Boyle County - Fiscal Year 2022

Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

AmeriCorps members served 41,112 students and provided food support services to 56,877 students. Serve Kentucky also provided housing services to 2,073 individuals.

AmeriCorps has 9 members in Boyle County.

Kentucky Transitional Assistance Program (KTAP)

Your county has received \$275,625 in KTAP issuance. This has been allocated to 100 households in the past fiscal year.

On average, SNAP serviced 3,197 people a month in Boyle County, stretching over 1,518 households. Total SNAP spending in your county in FY2022: \$8,558,289

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Boyle County received \$544,946 in funding, grants, community cash, and in-kind contributions with 10 full-time staff and 0 part-time staff.

As of 7/3/2022, there were 30 children in Out of Home Care, 28 of which received a per-diem, for a daily per-diem of \$2,393.

23% of children in the state's care had a goal of adoption. 76% had a goal other than adoption (e.g. reunification).

Boyle County received \$720,492 from the Child Care Assistance Program issuance supporting up to 212 providers a month.

The Division of Child Support Enforcement served on average 1,296 children a month, collecting \$1,924,553 in current and past due child support during FY 2022. They established 122 orders.

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 8,152 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 23,088 of the 58,079 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 2,003 prescribers and 352 dispenser DEA numbers.
