Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Bracken County received \$322,178 in funding, grants, community cash, and in-kind contributions with 3 full-time staff and 2 part-time staff.

As of 7/3/2022, there were 23 children in Out of Home Care, 23 of which received a per-diem, for a daily per-diem of 2,016.

34% of children in the state's care had a goal of adoption. 65% had a goal other than adoption (e.g. reunification).

Bracken County received \$111,204 from the Child Care Assistance Program issuance supporting up to 34 providers a month. The Division of Child Support Enforcement served on average 365 children a month, collecting \$634,535 in current and past due child support during FY 2022. They established 15 orders.
