


Breathitt County - Fiscal Year 2024

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$461,473 in KTAP issuance. This has been allocated to 116 households in the past fiscal year.

Health Services

Funding to Breathitt County Health Department: \$1,708,487

During fiscal year 2024, in Breathitt county there were 2 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 376 participants who received benefits totaling \$381,883.

There are 3 WIC-approved grocers in Breathitt County.

Division of Family Resource and Youth Services Centers (FRYSC)

Breathitt County received \$292,601 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 2,007, and 70% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$312,711. Additional grants totaled \$2,950.

Breathitt County received \$379,466 from the Child Care Assistance Program issuance, supporting up to 105 providers a year.

The Division of Child Support Enforcement served 938 children, collecting \$984,698 in current and past due child support, during fiscal year 2024. The agency established 980 orders.

There were 54 children cared for by foster families, 51 of whom received a combined per-diem totaling \$4,238.

50% of children in foster care had a goal of adoption. 50% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 4,647 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 25,444 of the 49,679 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,135 prescribers and 240 dispenser DEA numbers.

The Office of Inspector General completed 284 background checks for children & elderly services in Breathitt county fiscal year 2024.
