Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Edmonson County received \$394,602 in funding, grants, community cash, and in-kind contributions with 5 full-time staff and 0 part-time staff.

As of 7/3/2022, there were 35 children in Out of Home Care, 24 of which received a per-diem, for a daily per-diem of 1,680.

14% of children in the state's care had a goal of adoption. 85% had a goal other than adoption (e.g. reunification).

2 child(ren) adopted (YTD)

Edmonson County received \$194,179 from the Child Care Assistance Program issuance supporting up to 60 providers a month. The Division of Child Support Enforcement served on average 525 children a month, collecting \$748,236 in current and past due child support during FY 2022. They established 23 orders.
