Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 688 AmeriCorps members served 750,569 hours and recruited 4,705 volunteers who provided 181,290 hours of volunteer service (valued at \$5,429,636). AmeriCorps members served 45,685 students and provided food support services to 2,609 students. Serve Kentucky also provided housing services to 1,730 individuals and collected 75,035 pounds of food for individuals facing food insecurity.

AmeriCorps has 1 members in Elliott County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$148,895 in KTAP issuance. This has been allocated to 52 households in the past fiscal year.

On average, SNAP supported 1,450 people a month in Elliott County, stretching over 643 households.

Division of Family Resource and Youth Services Centers (FRYSC)

Elliott County received \$153,720 in funding. Donations and volunteer time totaled \$1,500. Additional grants totaled \$102,700. Throughout the Commonwealth 84% of all enrolled students received at least one FRYSC service. Over 26,000 caregivers participated in Grandparent/Relative Support Groups, and over 36,000 students participated in FRYSC-sponsored mentoring programs.

Elliott County received \$2,900 from the Child Care Assistance Program issuance, supporting up to 6 providers a month.

The Division of Child Support Enforcement served 373 children, collecting \$476,943 in current and past due child support, during fiscal year 2023. The agency established 389 orders.

There were 3 children cared for by foster families, 3 of whom received a combined per-diem totaling \$615.

33% of children in foster care had a goal of adoption. 66% had a goal other than adoption (e.g. reunification).

According to KASPER data, 1,604 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 6,893 of the 13,750 total controlled prescriptions dispensed.

The Office of Inspector General completed 50,778 background checks for children & elderly services across the Commonwealth of Kentucky in fiscal year 2023.
