Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 1 members in Elliott County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$228,097 in KTAP issuance. This has been allocated to 56 households in the past fiscal year.

During fiscal year 2024, in Elliott county there were 4 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.

Division of Family Resource and Youth Services Centers (FRYSC)

Elliott County received \$135,911 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 891, and 72% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$16,899.

Additional grants totaled \$0.

Elliott County received \$56,190 from the Child Care Assistance Program issuance, supporting up to 19 providers a year.

The Division of Child Support Enforcement served 371 children, collecting \$492,307 in current and past due child support, during fiscal year 2024. The agency established 374 orders.

There were 16 children cared for by foster families, 12 of whom received a combined per-diem totaling \$1,550.

12% of children in foster care had a goal of adoption. 87% had a goal other than adoption (e.g. reunification).

According to KASPER data, 1,685 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 7,215 of the 14,507 total controlled prescriptions dispensed.
