

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 4 members in Fleming County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$227,905 in KTAP issuance. This has been allocated to 58 households in the past fiscal year.



On average, SNAP supported 2,352 people a month in Fleming County, stretching over 1,069 households.

Health Services

Funding to Fleming County Health Department: \$438,476

During fiscal year 2024, in Fleming county there were 9 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 406 participants who received benefits totaling \$384,397.

There are 2 WIC-approved grocers in Fleming County.

Division of Family Resource and Youth Services Centers (FRYSC)

Fleming County received \$242,350 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 2,206, and 60% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$195,959. Additional grants totaled \$0.

Fleming County received \$234,471 from the Child Care
Assistance Program issuance, supporting up to 70
providers a year.

The Division of Child Support Enforcement served 550 children, collecting \$959,622 in current and past due child support, during fiscal year 2024. The agency established 529 orders.

There were 11 children cared for by foster families, 9 of whom received a combined per-diem totaling \$818.

45% of children in foster care had a goal of adoption. 54% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 4,626 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 12,679 of the 32,685 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,468 prescribers and 208 dispenser DEA numbers.

Fleming County is served by the Comprehend Community Mental Health Center. Comprehend received \$3,859,754 in fiscal year 2024.

Comprehend served 2,207 individuals in their region in fiscal year 2024.



Fleming is located in the Comprehend region. This region received \$593,282 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 139 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 308 background checks for children & elderly services in Fleming county fiscal year 2024.
