Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Floyd County received \$1,241,481 in funding, grants, community cash, and in-kind contributions with 12 full-time staff and 0 part-time staff.

As of 7/3/2022, there were 110 children in Out of Home Care, 109 of which received a per-diem, for a daily per-diem of 8,377.

24% of children in the state's care had a goal of adoption. 75% had a goal other than adoption (e.g. reunification).

Floyd County received \$232,678 from the Child Care Assistance Program issuance supporting up to 93 providers a month. The Division of Child Support Enforcement served on average 2,655 children a month, collecting \$3,304,348 in current and past due child support during FY 2022. They established 148 orders.
