Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Gallatin County received \$427,585 in funding, grants, community cash, and in-kind contributions with 3 full-time staff and 1 part-time staff.

As of 7/3/2022, there were 9 children in Out of Home Care, 8 of which received a per-diem, for a daily per-diem of \$575.

11% of children in the state's care had a goal of adoption. 88% had a goal other than adoption (e.g. reunification).

Gallatin County received \$240,553 from the Child Care Assistance Program issuance supporting up to 51 providers a month. The Division of Child Support Enforcement served on average 369 children a month, collecting \$704,359 in current and past due child support during FY 2022. They established 39 orders.
