

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 1 members in Grant County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$334,886 in KTAP issuance. This has been allocated to 91 households in the past fiscal year.



On average, SNAP supported 3,131 people a month in Grant County, stretching over 1,245 households.

Health Services

Funding to Northern Kentucky District Health Department: \$10,193,947

During fiscal year 2024, in Grant county there were 16 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 1,045 participants who received benefits totaling \$804,849.

There are 2 WIC-approved grocers in Grant County.

Division of Family Resource and Youth Services Centers (FRYSC)

Grant County received \$509,508 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 4,187, and 62% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$344,103.

Additional grants totaled \$2,000.

Grant County received \$2,109,544 from the Child Care
Assistance Program issuance, supporting up to 415
providers a year.

The Division of Child Support Enforcement served 1,420 children, collecting \$3,119,270 in current and past due child support, during fiscal year 2024. The agency established 1,340 orders.

There were 47 children cared for by foster families, 42 of whom received a combined per-diem totaling \$2,994.

8% of children in foster care had a goal of adoption.

91% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 7,501 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 22,231 of the 50,682 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 2,170 prescribers and 255 dispenser DEA numbers.
