



Henry County - Fiscal Year 2022

Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

AmeriCorps members served 41,112 students and provided food support services to 56,877 students. Serve Kentucky also provided housing services to 2,073 individuals.

Kentucky Transitional Assistance Program (KTAP)

Your county has received \$79,663 in KTAP issuance. This has been allocated to 28 households in the past fiscal year.

On average, SNAP serviced 1,438 people a month in Henry County, stretching over 644 households. Total SNAP spending in your county in FY2022: \$3,840,249

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Henry County received \$420,463 in funding, grants, community cash, and in-kind contributions with 4 full-time staff and 1 part-time staff.

As of 7/3/2022, there were 13 children in Out of Home Care, 11 of which received a per-diem, for a daily per-diem of \$1,075.

7% of children in the state's care had a goal of adoption. 92% had a goal other than adoption (e.g. reunification).

Henry County received \$121,850 from the Child Care
Assistance Program issuance supporting up to 47 providers
a month.

The Division of Child Support Enforcement served on average 813 children a month, collecting \$1,586,425 in current and past due child support during FY 2022. They established 28 orders.

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 5,169 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 14,784 of the 35,831 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,935 prescribers and 260 dispenser DEA numbers.

Henry County is served by the Seven Counties Community Mental Health Center. Seven Counties received \$22,200,523 in FY 2022.

Seven Counties served 25,555 individuals in their region.



Henry is located in the Seven Counties Community Mental Health Center region. This region received \$5,335,241 in Kentucky Opioid Response Effort (KORE) funding for FY 2022.
