Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Jessamine County received \$925,916 in funding, grants, community cash, and in-kind contributions with 12 full-time staff and 0 part-time staff.

As of 7/3/2022, there were 62 children in Out of Home Care, 54 of which received a per-diem, for a daily per-diem of \$5,400.

20% of children in the state's care had a goal of adoption. 79% had a goal other than adoption (e.g. reunification).

10 child(ren) adopted (YTD)

Jessamine County received \$2,142,017 from the Child Care Assistance Program issuance supporting up to 522 providers a month. The Division of Child Support Enforcement served on average 2,301 children a month, collecting \$3,602,487 in current and past due child support during FY 2022. They established 85 orders.

According to KASPER data, 15,074 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 47,190 of the 110,639 total controlled prescriptions dispensed.
