Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 0 members in Logan County.

#### Kentucky Transitional Assistance Program (KTAP)

Your county received \$253,202 in KTAP issuance. This has been allocated to 75 households in the past fiscal year.

Funding to Barren River District Health Department: \$8,006,577

During fiscal year 2024, in Logan county there were 10 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 725 participants who received benefits totaling \$666,299.

There are 5 WIC-approved grocers in Logan County.

## Division of Family Resource and Youth Services Centers (FRYSC)

Logan County received \$532,407 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 4,562, and 56% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$370,637.

Additional grants totaled \$2,000.

Logan County received \$1,107,911 from the Child Care Assistance Program issuance, supporting up to 274 providers a year.

The Division of Child Support Enforcement served 1,410 children, collecting \$1,908,554 in current and past due child support, during fiscal year 2024. The agency established 1,287 orders.

There were 34 children cared for by foster families, 31 of whom received a combined per-diem totaling \$2,561.

67% of children in foster care had a goal of adoption. 32% had a goal other than adoption (e.g. reunification).

#### Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 7,504 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 20,899 of the 51,515 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,805 prescribers and 209 dispenser DEA numbers.
