

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Nicholas County received \$325,000 in funding, grants, community cash, and in-kind contributions with 1 full-time staff and 0 part-time staff.

As of 7/3/2022, there were 8 children in Out of Home Care, 7 of which received a per-diem, for a daily per-diem of \$794.

62% of children in the state's care had a goal of adoption. 37% had a goal other than adoption (e.g. reunification).

Nicholas County received \$165,899 from the Child Care Assistance Program issuance supporting up to 39 providers a month. The Division of Child Support Enforcement served on average 471 children a month, collecting \$795,654 in current and past due child support during FY 2022. They established 17 orders.
