Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

AmeriCorps members served 41,112 students and provided food support services to 56,877 students. Serve Kentucky also provided housing services to 2,073 individuals.

AmeriCorps has 4 members in Pendleton County.

Kentucky Transitional Assistance Program (KTAP)

Your county has received \$207,954 in KTAP issuance. This has been allocated to 57 households in the past fiscal year.

Office for Children with Special Health Care Needs

In Pendleton County, there are 2,119 children enrolled in Medicaid.

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Pendleton County received \$362,167 in funding, grants, community cash, and in-kind contributions with 2 full-time staff and 0 part-time staff.

As of 7/3/2022, there were 33 children in Out of Home Care, 24 of which received a per-diem, for a daily per-diem of \$1,404.

15% of children in the state's care had a goal of adoption. 84% had a goal other than adoption (e.g. reunification).

4 child(ren) adopted (YTD)

Pendleton County received \$287,186 from the Child Care Assistance Program issuance supporting up to 65 providers a month.

The Division of Child Support Enforcement served on average 842 children a month, collecting \$1,485,156 in current and past due child support during FY 2022. They established 46 orders.

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 3,912 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 12,245 of the 28,627 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,529 prescribers and 203 dispenser DEA numbers.

Pendleton County is served by the Northkey Community Mental Health Center. Northkey received \$8,417,964 in FY 2022.

Northkey served 11,278 individuals in their region.



Pendleton is located in the Northkey Community Mental Health Center region. This region received \$3,271,755 in Kentucky Opioid Response Effort (KORE) funding for FY 2022.
