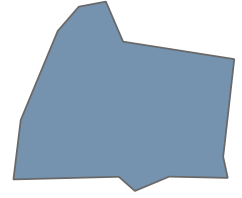

**AmeriCorps**  
Kentucky

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 0 members in Simpson County.

### Kentucky Transitional Assistance Program (KTAP)

Your county received \$188,995 in KTAP issuance. This has been allocated to 60 households in the past fiscal year.

On average, SNAP supported 2,237 people a month in Simpson County, stretching over 974 households. Total SNAP spending in your county in fiscal year 2024: \$4,375,100

## Health Services

Funding to Barren River District Health Department:

During fiscal year 2024, in Simpson county there were 8 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 538 participants who received benefits totaling \$491,960.

There are 3 WIC-approved grocers in Simpson County.

## Division of Family Resource and Youth Services Centers (FRYSC)

Simpson County received \$379,745 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 3,134, and 65% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$118,428. Additional grants totaled \$21,000.

Simpson County received \$572,899 from the Child Care Assistance Program issuance, supporting up to 150 providers a year.

The Division of Child Support Enforcement served 1,117 children, collecting \$2,099,781 in current and past due child support, during fiscal year 2024. The agency established 1,126 orders.

There were 51 children cared for by foster families, 45 of whom received a combined per-diem totaling \$3,625.

15% of children in foster care had a goal of adoption.  
84% had a goal other than adoption (e.g. reunification).

## Behavioral Health Services

### Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 5,061 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 14,837 of the 32,559 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,434 prescribers and 181 dispenser DEA numbers.
