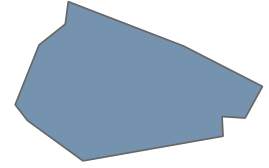

Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

AmeriCorps members served 41,112 students and provided food support services to 56,877 students. Serve Kentucky also provided housing services to 2,073 individuals.

Kentucky Transitional Assistance Program (KTAP)

Your county has received \$161,658 in KTAP issuance. This has been allocated to 39 households in the past fiscal year.

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Spencer County received \$315,162 in funding, grants, community cash, and in-kind contributions with 3 full-time staff and 1 part-time staff.

As of 7/3/2022, there were 49 children in Out of Home Care, 45 of which received a per-diem, for a daily per-diem of \$3,144.

26% of children in the state's care had a goal of adoption.
73% had a goal other than adoption (e.g. reunification).

2 child(ren) adopted (YTD)

Spencer County received \$319,591 from the Child Care Assistance Program issuance supporting up to 86 providers a month.

The Division of Child Support Enforcement served on average 480 children a month, collecting \$1,009,490 in current and past due child support during FY 2022. They established 19 orders.

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 5,776 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 15,201 of the 39,091 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 2,451 prescribers and 308 dispenser DEA numbers.

Syringe Services Programs

Spencer County is served by the Seven Counties Community Mental Health Center. Seven Counties received \$22,200,523 in FY 2022.

Seven Counties served 25,555 individuals in their region.



Spencer is located in the Seven Counties Community Mental Health Center region. This region received \$5,335,241 in Kentucky Opioid Response Effort (KORE) funding for FY 2022.
