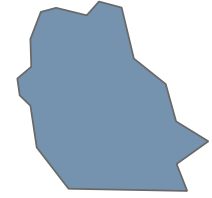

Across the entire Commonwealth of Kentucky 3,729 Serve Kentucky volunteers provided 792,753 hours of volunteer service (valued at \$1,032,063) in a little over a year between August 2020 and August 2021.

AmeriCorps members served 41,112 students and provided food support services to 56,877 students. Serve Kentucky also provided housing services to 2,073 individuals.

AmeriCorps has 4 members in Whitley County.

Kentucky Transitional Assistance Program (KTAP)

Your county has received \$875,503 in KTAP issuance. This has been allocated to 258 households in the past fiscal year.

Division of Family Resource and Youth Services Centers (FRYSC)

FRYSC in Whitley County received \$1,388,339 in funding, grants, community cash, and in-kind contributions with 15 full-time staff and 4 part-time staff.

As of 7/3/2022, there were 129 children in Out of Home Care, 98 of which received a per-diem, for a daily per-diem of \$6,124.

18% of children in the state's care had a goal of adoption.
81% had a goal other than adoption (e.g. reunification).

7 child(ren) adopted (YTD)

Whitley County received \$559,329 from the Child Care Assistance Program issuance supporting up to 200 providers a month.

The Division of Child Support Enforcement served on average 2,479 children a month, collecting \$2,745,456 in current and past due child support during FY 2022. They established 69 orders.

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 10,719 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 51,236 of the 107,397 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 2,146 prescribers and 332 dispenser DEA numbers.
