This will be achieved with Dementia Live®, an experiential learning program simulating cognitive and sensory impairments, giving participants a real-life experience of living with dementia. Participants are empowered with new tools for improved communication skills and care practices that can be implemented as they go about their work in the facility. These improved communication skills and care practices will ultimately help decrease resident behavioral symptoms that arise from dementia related conditions and help increase resident well-being.

## **Improving Quality of Care Through Culture Change**

The Change Team will learn how to identify the most pressing areas of concern, create an action plan to address, and effectively communicate efforts to all stakeholders. Expected outcomes include improvement of nursing staff and resident satisfaction scores, improvement of nursing competency assessment scores, and improvement in total nurse staff turnover.

This 3-year project is aimed at enhancing workforce stability in certified nursing facilities (CNF) by providing CNFs with access to Drive's "Mastering Recruitment & Retention Webinar Series." This online program focuses on equipping CNF administrators and HR professionals with effective strategies for attracting and retaining skilled staff. Access to the program will be provided to 1 staff member per CNF, per year for 3 years, for a potential of up to 897 trained staff by project end. The project is designed to strengthen the workforce in CNFs across the state, ultimately leading to improved resident care and operational sustainability. In collaboration with LeadingAge Kentucky.

# 2025 MDS/RAI Training

Successful and accurate coding of MDS assists direct care staff with development of a resident-centered plan of care, and mitigates excessive charges, fraud, waste and abuse of Medicare funds.

# **Improving Person-Centered Care Through Reminiscence Social Engagement**

## **Skin Integrity Education Initiative**

Goal: The purpose of this three-year project is to establish a sustainable nurse education program that will enhance staff proficiency in wound care in four Kentucky certified nursing facilities (CNFs) with a comprehensive training curriculum, monthly workshops, and hands-on skill-building sessions. This wound care education program will directly benefit nursing home residents by improving healing, reducing risks of complications, and assisting with providing personalized, compassionate care. With better-trained staff, residents will experience more comfort, faster healing, and a higher overall quality of life.

# **Enhancing Resident Engagement with the Obie Mobile Projector**

Goal: The purpose of this one-year project is to improve the nursing home residents' quality of life by using the Obie Mobile Projector to foster meaningful interactions, reduce feelings of isolation, and provide therapeutic benefits without medication. The Obie Mobile Projector is an interactive tool that provides cognitive stimulation, social interaction, and emotional engagement through touch-based games and activities. The projector allows for flexible engagement on floors, tables, walls, and bedside surfaces, ensuring personalized experiences for each resident.

### Partners in Healing: Strengthening Wound Care Services in Kentucky

Goal: The purpose of this two-year project is to train four Wound Care Specialists per facility, for a total of 39 Signature Healthcare nursing home facilities, to elevate and enhance the well-being of the residents while equipping staff with the necessary knowledge and skills. Implementing this training will certify Wound Care Specialists at each facility in two years, resulting in a 75% pass rate, increasing resident satisfaction of at least 85%, and reducing hospital visits and costs associated with wound infection, preventing the resident(s) from being relocated to different care facilities.

# Improving Dementia Capability with CARES Dementia 5-Step Method

Goal: This three-year initiative aims to enhance dementia care by training and certifying at least 15% of direct care staff in 64 facilities using three evidence-based, person-centered CARES® online programs: the Dementia 5-Step Method, Dementia Safety Topics, and Dementia-Related Behavior. The project addresses the issue of staff being underprepared to manage dementia-related behaviors, which can lead to negative interactions between residents and caregivers. By implementing this training, the project seeks to improve person-centered care, reduce resident anxiety, and decrease the use of antipsychotic medications.
