Licensed Type I, Type II and Certified Providers may contact the DRCC operations branch for:

- Questions regarding initial and renewal application processes
- Reporting a <u>temporary or permanent</u> program closure, including closures for inclement weather
- Requesting a change to currently approved services or addition of a new service
- Reporting a change in contact information such as email or telephone number
- Reporting a change of director

Prospective providers may contact the DRCC operations branch for information related to the first-time application or a change of ownership process.

To report an accident, incident, or injury that occurred at your licensed center or certified family child care home, call or email the DRCC call center. Reports should include the name and license number of your facility or certified home, details about the incident such as names of staff involved, name and age of children involved, dates, location where incident occurred, and a brief description of the event. See 922 KAR 2:090 Section 13 for an extensive list of reporting requirements.

Complaints of regulatory violations and reports of unapproved child care may also be submitted to the DRCC Call Center.
